## TUSCALOOSA COUNTY PARK & RECREATION AUTHORITY DRUG AND ALCOHOL CONSENT/RELEASE FORM

I authorize the Medical Review Officer to release to PARA.

I expressly authorize the PARA or its Medical Review Officer to release any test-related information, including positive results, to the Unemployment Compensation Agency, or any other relevant government agency.

I understand that I am subject to post-accident testing, and I must remain available, or my employer may consider me to have refused to submit to testing. I must refrain from consuming alcohol for eight hours following the accident, or until I submit to an alcohol test. I also understand that if this test is being conducted because of an accident I was involved in, and I refuse to submit to standards adopted by the U.S. Department of Transportation in 49 C.F.R. 40 and 382, as amended, that such refusal will forfeit my rights to recover worker's compensation benefits as set forth in <u>Alabama Code</u> 25-5-1 et seq., as well as unemployment compensation benefits.
